

Obesity Benefit Synopsis

Blue Cross Blue Shield of Wyoming has updated procedure codes related to obesity coverage and preventative benefits. Preventive diet, behavioral, and medical counseling are permitted for obesity under the US Preventive Service Task Force recommendations. These standard preventive benefits apply to all fully insured lines of business but can vary for self-funded groups.

Diagnoses: Diabetes, prediabetes, obesity, overweight, hyperlipidemia, hypertension, and certain genetic disorders.

Age Limits: Ages 6 – 18: 26 visits per calendar year. Age 19 & Older: 12 visits per calendar year. These accumulate per provider, per date of service.

Bariatric Surgery

Surgery for obesity will be a Covered Service only when required due to morbid obesity. Benefits will only be paid when:

(1) The member has a body mass index (BMI) of 40 or greater, or

(2) The member has a BMI of 35 to 39.99 with a co-morbidity

IMPORTANT NOTE: Authorization by Blue Cross Blue Shield of Wyoming is required for Surgery for obesity.
