Dear Pharmacists,

As a valued BCBSWY partner, we want you to have updated information to maintain member expectations and for timely andaccurate claims processing. Please ensure you are filing electronic claims to include the information below.

- The pharmacist NPI must be submitted in the prescriber field. If the pharmacist on duty does not have a NPI, the pharmacy NPI may be submitted along with a submission clarification code of "42" to avoid
- claim rejections for these OTC products.
- The Prescriber Type must be entered as "01" to indicate an NPI number and not as a DEA number for correct processing.
 Please review the list of covered OTC COVID-19 at-home testing products below to avoid claim rejections.

Additional Information:

For greatest compliance and reduced customer abrasion, pharmacies dispensing the OTC COVID-19at-home tests should ensure the following:

- a. Submit claims via the online prescription claim system whenever possible.
- b. Verify and document at the time of dispensing that the Covered Person is not obtaining tests for employment purposes or for resale, which is not covered under the pharmacy benefit.
- c. Test kits should be submitted with no refills. Each dispensing event should have a new RXnumber assigned with no refills allowed.

We encourage you to submit the claims online to ensure members receive tests with no out-of-pocket costs. With your partnership, we can satisfy both the mandate and member expectations to reduce questions and customer time in filing paper claims for reimbursement.
